Annual National Juried Show 2017

July 11 - 29, 2017 ■ Entry Deadline: March 24, 2017

Juror: Stuart Shils A native of Philadelphia, Stuart Shils is a noted painter who has been the recipient of grants and awards from the Pollock-Krasner Foundation, the National Endowment for the Arts, and the Academy of Arts and Letters in New York. He has also been a resident fellow at the Ballinglen Arts Foundation in Ballycastle, Ireland. His work is represented by Davis and Langdale Gallery and Steven Harvey Fine Art Projects in New York, and by Rothschild Fine Art in Tel Aviv. He studied at the Pennsylvania Academy of Fine Arts where he presently teaches painting and drawing.

Shils is known for his uniquely beautiful palette and painterly expression of light and shadow. Mr. Shils will give a lecture on his work at the gallery Friday, July 14 at 6 PM; the opening reception will be Saturday, July 15 from 3-6 PM.

ELIGIBILITY: Open to artists 18 + living in the USA. Original paintings, drawings, prints, and mixed media only. No giclees, digital prints, videos or photographs will be accepted.

DIMENSIONS: Work, including frame, must not exceed 36" in any direction, and should be wired, labeled, and ready to hang.

MAILED ENTRIES: For framed works on paper, plexiglass must be used instead of glass.

ENTRIES: Entry forms must be complete and submitted online only: www.princestreetgallery.com When you have completed the form, you will be directed to a secure PayPal site. It is not necessary to open a PayPal account. Through the gallery's PayPal account, you will be able to pay the entry fee with any credit card. Application is not complete until payment has been received.

ENTRY FEES: Non-refundable fee of \$35 for 1-3 works. \$5 for each additional piece. Maximum is 6 works for \$50. **IMAGE REQUIREMENTS:** JPEGS 72 dpi only, 1000 pixels wide minimum and 600 pixels tall minimum not to exceed 1 MB for any individual image. Please label JPEGS as follows: LAST name_FIRST name_ followed by letter that

corresponds with that work's placement on the entry form (A,B,C,D,E,F).

For Example:

degas_ed_A_jpg, degas_ed_B_.jpg or

cassat_mary_A_jpg, cassat_mary_B_jpg, artwork title on the jpeg is optional. Only use letters, underscore or dashes in the file name; don't use quote marks, hashtags, etc.

The accepted size of 36" should include the frame. Height is always given before width, regardless of whether the work is vertical or horizontal. SALES: Prince Street Gallery takes no commission on sales. Label work that is not for sale "NFS".

DELIVERY AND PICK-UP: Late arriving work cannot be hung. Work that is shipped must arrive in a reusable container, including a prepaid computer-generated UPS or FEDEX return shipping label. No U.S. Postal Service returns. Do not send stamps, cash, or credit card info for return of work. Any work not picked up after one month will be disposed of as the gallery sees fit.

LIABILITY: All possible care will be taken to guarantee safety of work. Prince Street Gallery's insurance will cover work ONLY while it is hanging in the gallery. The gallery will not bear liability for any loss or damage while in transit. Transit insurance is the responsibility of the artist.

Hand delivery of work: Fri. July 7 & Sat. July 8, 2017

Receiving shipped work: Sat., July 1, 2017 **Show dates:** Tues. July 11 – Saturday July 29

Lecture: Fri., July 14, 6 PM **Reception:** Sat., July 15, 3 – 6 PM

Pick up hand-delivered work: Sun., July 30; Mon., July 31. **UPS/FedEx return of shipped work:** Mon., July 31. *If six (6) months after the show closes you have not claimed your artwork, it will be disposed of at the discretion of the Prince Street Gallery.
